Person/firms, interested in purchasing the above mentioned materials may submit their bid in the prescribed format in a sealed cover addressed to the undersigned latest by 1.00 PM on or before 27.11.2024 at Office of the Addl. Director And CHD, Industries & Commerce Department BTC, Kokrajhar. The bids will be opened on the same day at 2.00 PM. The bidder(s) or their representative(s), not more than one for each quotation, may be present, if they so desire, at the time of opening of bids. The cover should be prominently superscripted with the words "QUOTATION FOR PURCHASE OF ASSAM TYPE COMMERCIAL SHED AT TAMULPUR, BTR".

The Auction will be governed by the following terms and Conditions:-

1. The materials will be sold on "as is where is basis".
2. The auction process will be conducted in presence of the constituted Auction/Tender committee.
3. The bidders are required to furnish Earnest Money of Rs. 2000.00 (Rupees Two thousand only) along with the bid.
4. Earnest Money is payable by means of Demand Draft drawn in favour of " Addl. Director and CHD, Industries & Commerce Department BTC, Kokrajhar" (payment by cheque or cash shall not be accepted).
5. Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.
6. The successful bidder will be required to deposit the bid amount by means of Demand Draft pledging in favour of "The Principal Secretary, BTC, Kokrajhar" within 7 days of issue of letter of acceptance.
7. The Earnest Money of the successful bidder will be released only after completion of the work. Earnest Money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid. In case of failure to deposit final bidding amount, the authority reserve the right to cancel the bidding process and re invite the bids for auction. In such case the Earnest money submitted by the HI-1 bidder will be forfeited.

8. On submission of application by the unsuccessful bidder EMD will be released within one month after completion of the process.
9. The bidder will have to submit documentary evidence in support of the ID & address proof (PAN Card, Voter ID, AADHAR Card. in case of individual and Registration certificate etc. in case of firms.
10. The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
11. The Auction/Tender Committee reserves the right to accept or reject any/all of the quotation without assigning any reason.
12. Bidders may inspect the sites before submission of the bid at their own cost and risk.
13. Format for offering rate for disposal of damaged materials may obtain from the office of the undersigned during office hours.
14. In case the successful bidder fails to clear the sites within the 15 days of time of issue of order ,no claims for the materials left at site will be entertained and the department will do the same at the cost of successful bidder and the cost will be adjusted from the earnest money of the successful bidder.
